Benchmark similar organization in order to propose, develop and implement best practices;</p> <p>Maintains and develops security risks' analysis, prevention and crisis plans for the ITER site;</p> <p>Develops and carries out the security action plan to be implemented within the integrated security management system for ITER (including guidelines, procedures, training and surveys);</p> <p>Supports and advices to all ITER design, engineering, procurement, construction and operation activities in the domain of French security regulations;</p> <p>Cooperates in the implementation of the Export Control, Non-Proliferation and Peaceful Uses policies and strategies within the ITER Organization;</p> <p>Cooperates in the implementation of the Intellectual property board;</p> <p>Provides regular safety reports and prepares relevant presentations;</p> <p>Performs duties related to Security, Health and Safety Division as requested by the Division Head in support of the fulfillment of the project schedule as described in the Detailed Work Schedule and the Strategic Management Plan;</p> <p>Performs other duties upon management request, as necessary;</p> <p>Maintains a strong commitment to the implementation and perpetuation of the ITER Safety Program, values and ethics.</p> <p>Reports to the Safety Department Head for activities related to the role and responsibilities of Officier de sécurité and to the Security, Health and Safety Division Head for other topics;</p> <p>Acts as an interface between all other ITER departments and the Domestic Agencies;</p> <p>In response to requests from the Director-General and/or Department Head, or proactively, informs the DG/ Department Head of any important and urgent issues that cannot be handled by the concerned line management and may jeopardize the achievement of the Project's objectives.</p> <p>Contributes efficiently to the development and implementation of security management plan of the ITER project;</p> <p>Responsible for risk analysis deliverables that meet security standards, quality schedule and</p>
