### **Purpose**

In the role of Control Systems Integration Engineer, you will ensure that design, manufacturing, and acceptance of a subset of ITER's Plant Systems are properly coordinated and compliant with the integrated ITER control system requirements. Additionally, you will propose, develop, and implement solutions to improve, support and maintain both the central Instrumentation and Control (I&C) functions interfacing with ITER Plant Systems, and the Data Acquisition (DAQ) and/or Real-Time (RT) controllers for the ITER Plant Systems.

### **Background**

The Controls Division is responsible for integrating ~170 plant systems in the central control system. I&C standards have been established and corresponding software frameworks developed. These are based on Siemens S7 series of Programmable Logic Controller (PLC),

Peripheral Component Interconnect Express (PCIe) based fast controllers, Ethernet TCP/IP communication and open source software (Linux, Experimental Physics and Industrial Control System – EPICS, Control System Studio, etc.). Integration started in 2018 and will continue up to first plasma in 2025 and beyond.

Central control system of ITER comprises conventional control (CODAC), Central Interlock System (CIS), and Central Safety Systems (CSS).

### **Major Duties/Roles & Responsibilities**

---

- Plans, organizes and executes the integration and commissioning of the defined scope for ITER's Plant Systems into the central control system;
- Contributes to the development of I&C integration plans and procedures for defined Plant Systems I&C; executes them, generates the associated tests and requirements' compliance reports;
- Interacts with Plant Systems I&C Responsible Officer(s) and suppliers to support the design and acceptance tests of ITER Plant Systems, whilst ensuring compliance to standards developed by the Control Division;
- Reviews and maintains the physical and functional interfaces between Plant System I&C and central control systems;
- Analyzes, defines and implements required changes to Plant System I&C and/or interfacing central I&C functions;
- Ensures that the I&C integration procedures are correctly executed, identifies issues, proposes solutions and implements them accordingly;
- Provides adaptive and corrective maintenance actions after the acceptance of ITER Plant Systems;
- Contributes to the development of test facilities which allow I&C development and verification off line;
- Collaborates with Machine Operation Stakeholders to support commissioning activities, and participates in the commissioning and operation of Plant Systems;
- Ensures the Plant Control Design Handbook documentation is up to date, especially in the areas of Plant System I&C architecture and interface standards;
- Implements and documents for Data Acquisition and/or Real-Time control software, in addition to Human Machine Interface (HMI) software as per I&C needs;
- Contributes to the management and/or technical oversight of contracts to supply standard equipment, as well as contracts to support integration, commissioning and maintenance activities in close collaboration with the Procurement and Contracts Division;
- May be requested to be part of any of the project/construction teams and to perform other duties in support of the project;
- May be required to work outside ITER Organization reference working hours, including nights, week-ends and public holidays.

- Integrates Plant Systems I&C in central control system within the defined scope, quality and schedule;
- Proposes and implements solutions for problems encountered in a timely manner, to achieve the integration, commissioning, and operation schedule;
- Monitors and supervises properly diagnostics, developments, tests, and analyses in compliance with existing procedures of the integrated ITER control system;
- Maintains excellent relations with stakeholders, as well as physical and functional interfacing systems;
- Keeps documentation related to ITER Plant System I&C accurate and up to date.

- **Professional Experience:**

- At least 8 years' experience working as Control Software Engineer in managing and coordinating the design, installation, and commissioning of large-scale scientific or industrial control systems.

- **Education:**

- Master degree or equivalent in Electronics, Computer Science, Electro-mechanics or other relevant discipline;
- The required education degree may be substituted by extensive professional experience involving similar work responsibilities and/or additional training certificates in relevant domains.

- Executing and coordinating the integration and commissioning of heterogeneous I&C systems, including identifying and resolving issues;
- Using Linux, virtualization environments and real-time operating systems;
- Using C++ and Field Programmable Gate Array (FPGA) in the context of DAQ and RT control applications;
- Applying high-integrity software quality assurance processes;
- Using EPICS and/or other commercial or open-source SCADA systems is desirable;
- Contract management and execution: defines requirements, monitors execution and manages external parties to ensure implementation and/or delivery within contractual scope (cost, quality, schedule, etc.);
- Writing and presentation; write, review, and deliver technical documents, transmitting knowledge and data with clarity and precision, adapted to the audience;
- Working on Human Machine Interface (HMI) development is considered advantageous;
- Being proficient with platforms such as National Instruments LabVIEW FPGA, FlexRIO, and CompactRIO is considered advantageous.
